Meetings: The Board of Studies shall meet at least twice a year. **Term**: The term of the nominated members shall be two years.

Functions:

The Board of Studies of a Department in the college shall:

- a) Prepare syllabi for various courses keeping in view the objectives of the college, interest of the stakeholders and national requirement for consideration and approval of the Academic Council;
- b) Suggest methodologies for innovative teaching and evaluation techniques;
- c) Suggest panel of names to the Academic Council for appointment of examiners; and
- d) Coordinate research, teaching, extension and other academic activities in the department/college.
- e) To prepare model question papers for the course concerned as and when there is a revision of syllabus.
- f) To recommend to the Academic Council in regard to prescribing text books, and reference books and the scheme of study and examinations in the course concerned.
- g) To consider and report on any matter referred to it by the Academic Council, Governing Body or the principal.
- h) To recommend to SITE the qualifications required to teach a particular course/subject/paper.
- i) To recommend to the Academic Council the starting of any new programmes in the Department concerned.
- j) To recommend to SITE the pass/class/grade regulations for the programmes offered.
- k) To frame the syllabi and model question papers for the entrance tests for admission into the programmes of study conducted by SITE.
- 1) To prepare a panel of experts to be on the Selection Committees for selection of teachers, which will be submitted to the Governing Body for approval.
